**TRINATRACKER (NCLAVE RENEWABLE SLU y NCLAVE MANUFACTURING SLU)** has been providing services of design, manufacture and installation of fixed structures and solar trackers since its incorporation. The Management of **TRINATRACKER** through this policy has decided to integrate Quality, Environment, Health and Safety Management and Energy Management and to include it in the strategic plans of the company, declaring and assuming the following **basic principles**:

- ♦ Delivery to the customer of quality products, free of faults, environmentally friendly and safely manufactured.

In order to achieve these principles, we have decided to integrate, maintain and periodically review an **Integrated Management System** certified in accordance with the **UNE-EN-ISO 9001** (Quality Management Systems), **UNE-EN-ISO 14001** (Environmental Management Systems), **UNE-EN-ISO 45001** (Occupational Health and Safety Management Systems), **UNE-EN-ISO 50001** (Energy Management) standards. **In addition, we aim to achieve excellence in the manufacture of our products in accordance with the UNE EN 1090 and ISO 3834 standards.**

The **general principles** that support our Policy are as follows:
